## Introduction:

# Personal data that we process

Easy Caravanning processes your personal data because you use our services and/or because you have provided them to us yourself. Information that Easy Caravanning needs from you or that is necessary for the purposes described below and that is processed by Easy Caravanning in any case and at least, concerns:

- Initials and surname
- Gender
- Date of birth
- Company name
- Address details (consisting of street name + house number + postal code)
- Telephone number (mobile or landline)
- E-mail address
- Bank details

# Does Easy Caravanning also process special personal data?

Special personal data are sensitive data, such as health or criminal history, ethnic or racial data. Easy Caravanning does not process any special personal data.

## Why we need data

Once you have an agreement with Easy Caravanning, we want to be of service to you. We use your data for the following purposes:

- To be able to call or e-mail you if this is necessary to be able to perform our services.
- Inform you about changes to our services and products.
- To deliver goods and services to you.
- If we are legally obliged to do so, such as information that we need for our tax return.

- Data may also be used for promotional or marketing purposes, which are in proportion to the type of service provided by Easy Caravanning. For example, to inform you via our newsletter about a new activity of Easy Caravanning.
